**Event Rules:**

1. All drivers must be 16 years of age or older. (Must provide proof of age via a valid driver's license along with vehicle registration and automobile insurance. Proof of vehicle ownership is required. No convertible vehicles. Check in by 6:30PM Mandatory Drivers meeting at 6:45PM
2. All drivers must wear a helmet and a seat belt. The drivers' side window must be rolled down.
3. **ABSOLUTELY NO ALCOHOL OR DRUGS BEFORE OR DURING THE STREETCAR EVENT**
4. Races will be from a dead start. Drivers will draw pills for starting positions. A bucket will be created to determine match ups. Lower number from initial draw will determine lane choice. One lap around the track with two participants lined: side by side. A false start will result in a disqualification. Intentional contact is not permitted. Winner will advance to the next round. Bracket is single elimination. Final race with the last two competitors will be a one lap race starting from a dead start. **First one across the finish line wins.**
